GLOBALG.A.P. is a trademark and a set of standards for good agricultural practices (G.A.P.). GLOBALG.A.P. standards and implementation are developed and defined by various Technical Committees, Focus Groups and the Certification Body Committee. National Technical Working Groups support the work of the committees on a local level. The Integrity Surveillance Committee (ISC) assesses integrity issues and certification body non-conformances, defines correctional measures and proposes sanctions.

FoodPLUS GmbH is a limited liability cooperation registered in Cologne, Germany. It manages all company's activities worldwide from standard setting through services for its partners, marketing, certification management to integrity and serves as legal entity to hold the international GLOBALG.A.P. and GGN (consumer label for GLOBALG.A.P. certified farms) copyrights. FoodPLUS GmbH is governed by an elected Advisory Boardconsisting of an equal number of representatives from retail/foodservice and producer/supplier organizations. Financial and legal ownership of FoodPLUS GmbH is held by the EHI Retail Institute e.V. via its 100% subsidiary EHI-Verwaltungsgesellschaft mbH. GLOBALG.A.P. North America Inc. is a USA corporation whose sole owner is FoodPLUS GmbH. The GLOBALG.A.P. Secretariat supports the work of the Advisory Board and all committees. This function is performed by FoodPLUS GmbH, a limited liability company based in Cologne, Germany, which acts as the sole management platform for GLOBALG.A.P. The management of FoodPLUS GmbH is responsible for the implementation of procedures and standards. In addition, it facilitates the GLOBALG.A.P. benchmarking process, manages the GLOBALG.A.P. database and implements decisions made by the ISC.

GLOBALG.A.P. Certification

GLOBALG.A.P. offers one core product: <u>GLOBALG.A.P. Certification</u> (<u>GLOBALG.A.P.</u> (<u>globalgap.org</u>), available for 3 scopes of production: **Crops**, Livestock, Aquaculture and consisting of a total of more than 40 standards.

IFA Plants Certification

The **IFA plants scope** covers hundreds of products and all types of production systems in the product categories (<u>Plants (globalgap.org)</u>: **Fruit and vegetables**; flowers and ornamentals; combinable crops; tea; hops; plant propagation material.

The standard defines clear criteria for responsible farming practices in primary production, from preharvest activities through to postharvest handling. Producers can be certified for multiple

product categories under the IFA plants scope in one certificate, and certification options are available for all sizes and types of farms, including smallholders.

IFA for Fruit and Vegetables

The IFA standard for fruit and vegetables (Fruit & Vegetables (globalgap.org) is a global standard for responsible farming practices at primary production level, covering preharvest activities such as soil management and plant protection product application, to basic postharvest handling. GLOBALG.A.P. standards for fruit and vegetables have been operational for over 20 years and are developed through extensive collaboration with stakeholders throughout the sector. IFA is aligned with the United Nations Global Compact Food and Agribusiness Principles and the Sustainable Development Goals.
